Regulation 823 – MFIPPA

1. The following are the fees that shall be charged for the purposes of subsection 45 (1) of the Act for access to a record:
  - a) For photocopies and computer printouts, 20 cents per page.
  - b) For floppy disks, \$10.00 for each disk.
  - c) For manually searching a record, \$7.50 for each 15 minutes spent by any person.
  - d) For preparing a record for disclosure, including severing a part of the record, \$7.50 for each 15 minutes spent by any person.
  - e) For developing a computer program or other method of producing a record from machine readable record, \$15.00 for each 15 minutes spent by any person.
  - f) The costs, including computer costs, that the institution incurs in locating, retrieving, processing and copying the record if those costs are specified in an invoice that the institution has received. O. Reg. 22/96, s. 2.
  
2. The following are the fees that shall be charged for the purposes of subsection 45 (1) of the Act for access to personal information about the individual making the request for access:
  - a) For photocopies and computer printouts, 20 cents per page.
  - b) For floppy disks, \$10.00 for each disk.
  - c) For developing a computer program or other method of producing the personal information requested from machine readable record, \$15.00 for each 15 minutes spent by any person.
  - d) The costs, including computer costs, that the institution incurs in locating, retrieving, processing and copying the personal information requested if those costs are specified in an invoice that the institution has received. O. Reg. 22/96, s. 2.
  
3. If a head gives a person an estimate of an amount payable under the Act and the estimate is \$100.00 or more, the head may require the person to pay a deposit equal to 50% of the estimate before the head takes any further steps to respond to the request. O. Reg. 22/96, s. 3.
  
4. A head shall refund any amount paid under subsection (1) that is subsequently waived. R.R.O. 1990, Reg. 823, s. 7 (2).
