## Mayor's Message

Council and I are proud to present the 2025 Budget. Our deliberations took a critical and comprehensive look at the entirety of Lakeshore's financial picture, and we made several difficult decisions. We continue to face significant financial challenges, including the ongoing impact of inflation as well as pending costs outlined in the Water and Wastewater Master and Fire Master Plans. In light of those pressures, the focus was on delivering value and limiting the impact on taxpayers.

We've delivered another budget

that is below the rate of inflation. I would like to thank my fellow Council members, Team Lakeshore for their fantastic work on the Budget, as well as to all the residents who shared their feedback.

Our list of capital projects, totaling over \$36 million, will see neighbourhood-enhancing investments in communities across Lakeshore. Stoney Point/Pointe-aux-Roches residents will see investments in their community park, and an accessible kayak launch system is coming to Belle River. We're replacing and connecting sidewalks and trails

to improve walkability and safety. Larger investments include \$2.9 million for road resurfacing, \$1.14 million for surface treatments, and several multimillion-dollar investments in our water and wastewater systems.

However, one budget is not an answer to the challenges we face. We will continue to look to community partners and upper levels of government for support in achieving our goals. While we are still early into 2025, I look forward to sharing important news about these opportunities soon.

Together we are Lakeshore.

## 2025 Budget

On Thursday, January 23, 2025, Council approved Lakeshore's 2025 Budget. The approved tax rate increase will add \$54 per year (\$4.50 per month) to the municipal portion of property tax bills. County of Essex and school board levies will add an additional \$55 per year (\$4.58 per month).




## Lakeshore Town Hall Renovations Reminder
