## Mayor’s Message: 2026 Budget Approved

I am pleased to announce that Lakeshore’s 2026 Budget has been approved at 1.76%.

The Budget is truly a Lakeshore-wide process which culminates in a document that guides investments in projects and services which will improve our communities for years to come.

I’d like to thank Council for their thoughtful input and constructive debate, staff for their expertise and management of the Budget, as well as all

the residents and community partners who reached out to us with their input.

This year’s deliberations took a line-by-line approach to find opportunities for savings on behalf of taxpayers. We are thrilled to deliver a Budget below the rate of inflation while continuing to invest in our services and our communities.

The steps taken throughout the process reflect the voices of residents of Lakeshore’s

communities, and I am confident that the Budget represents our collective desire to keep more money in the pockets of our taxpayers.

## 2026 Budget

On Thursday, December 4, 2025, Council approved Lakeshore’s 2026 Budget. The tax rate increase will add \$33 per year (\$2.75 per month) to the municipal portion of property tax bills. The County of Essex levy will add an additional \$34 per year (\$2.83 per month).  
\*School board rates were not available as of publication.

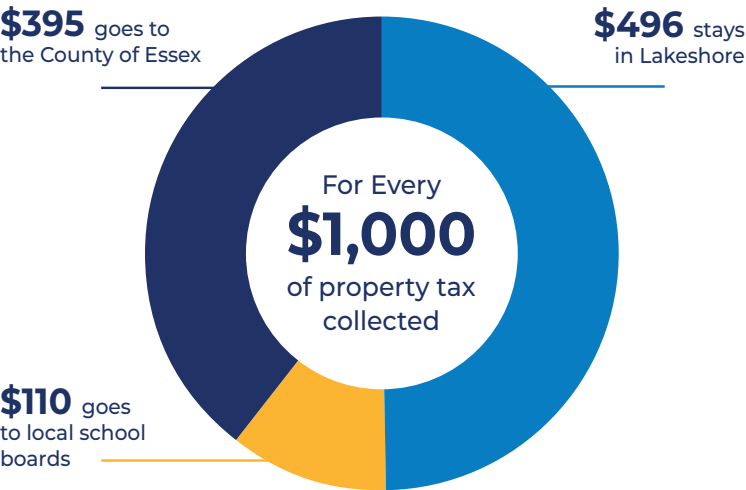

### Budget Highlights:

- Stoney Point Wastewater Treatment Plant Design
- \$9.2 million for road work, including reconstruction, asphalt resurfacing, surface treatment, and gravel road conversion.
- Amy Croft Widening and Intersection Improvements at Manning Rd
- Watermain replacements in Lighthouse Cove
- Scott Sideroad watermain connection
- Splash pad improvements at Lakeview Park, jet ski docks at Belle River Marina, and tennis/pickleball court replacement at Leffler Park
- Added funding to complete CWATS EC Way 100 Cycling Trail
- New funding for Community History and Identity Project

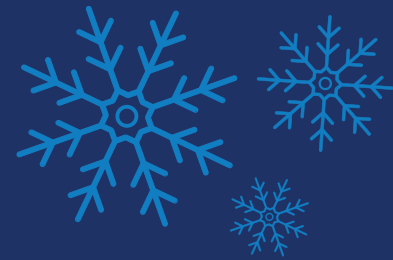
## Upcoming Tax Bills

Lakeshore issues two bills each year (Interim and Final). Bills will be mailed in January and June, with two payment due dates each:

- **February 27**
- **April 30**
- **July 31**
- **October 30**



Supplementary tax bills are also issued when a new home is built or renovated, or the property's land use changes.



## Snow Removal Reminder

After a significant snowfall, property owners must clear snow and ice from the sidewalks next to their property.

Keeping sidewalks clear helps everyone stay safe, especially kids, seniors, and anyone out for a walk.

**Remember:** while shovelling, please be careful not to damage the sidewalk or road.

## Changes to Recycling Collection

Starting in January 2026, recycling collection will no longer be a municipal responsibility. Circular Materials will be the new administrator across Ontario and they have hired Green For Life Environmental Inc. (GFL) to provide curbside recycling collection. Collection info in the 2026 Collection Calendar remains the same. Residents must have their recycling out by 6:00 AM.
